**New Ohio Employer Support of the Guard and Reserve Field Committee Chair.** Mr. John W. Hoppers will be sworn in by Assistant Secretary of Defense for Reserve Affairs, Lt.Gen. (Ret) Dennis McCarthy, on Tuesday, December 15, as the Ohio ESGR Field Committee Chair. Mr. Hoppers has been a member of ESGR since November 1994. In 1996 he was appointed Ohio Ombudsman coordinator. He follows COL (ret) Robert Labadie in this volunteer position. ESGR volunteers provide free education, consultation and if necessary mediation for employers of Guard and Reserve personnel.

**National Guard Birthday.** In recognizing the December 9<sup>th</sup> birthday of the National Guard, Representative Robert Latta (R-OH) proposed House Resolution 940, titled "Recognizing and Honoring the National Guard on the occasion of its 373rd Anniversary." In a statement issued by his office, Representative Latta said: "From the American Revolution to the current Global War on Terror, these citizen soldiers have defended the peace and security of America. It is important that we recognize the sacrifices of these service members and provide continued support to ensure its readiness and success." The resolution passed the House by a vote of 401-0 on December 8.

**Air National Guard Renewable Energy Projects.** The 180th Fighter Wing, Toledo, Ohio, has invested \$11.4 million of DoD Research and Development funds to design, build and evaluate the feasibility of on base electricity generation from renewable energy sources. This project is being accomplished to determine whether or not the construction of these facilities on small remotely

located National Guard installations can meet Air Force requirements for site renewable energy generation and carbon footprint reduction.

Over the past 3 fiscal years, the 180th has designed, constructed and operated a 783 KW Photovoltaic (solar) electric generation plant. Currently an additional 400 KW of electrical generation capacity is under construction and should be operational by July 1, 2010. The current operational 783 KW plant has the capability to generate approximately 30% of the 180th's annual electricity requirements or about 10% of the base's overall facility energy usage. In FY 2009 the base generated approximately 695 MW hours of electricity which was just over 21% of the base's total annual electrical consumption. This electrical generation saved the base \$120,000 due to the cost of displaced electricity, reduced demand charges and excess electricity which was sold to the local utility provider. The 180th FW has plans to expand this site to approximately 2 megawatts of peak electrical generation over the next 3 FYs. In addition, plans to develop on site energy storage capacity are in development. The 180th has been able to construct 95% of this solar field with products that are manufactured in Ohio and by using local contractors to assemble the system adding additional benefit to the local economy. Currently this Photovoltaic field is the largest operational solar field in the State of Ohio and the largest Air Force owned solar field in the inventory.

At Camp Perry, the 200<sup>th</sup> Red Horse Squadron currently has a similar renewable energy project operational. The \$3.37 million three phased project, authorized and funded in the 2009 Federal Military Construction budget, and completed in August, 2009, produced a 189 kW Photovoltaic Solar Field at Camp Perry Air National Guard Station, Port Clinton, Ohio. The Solar Field will produce approximately one third of the electrical demand for the installation. Excess power will be fed back into the electrical grid. The solar field is located on one acre of land and encompasses 2,592 panels. These panels were manufactured at First Solar located in Perrysburg, OH. Savings generated by the Solar Field resulted in 63,824 kilowatt hours, or \$6,346. This is enough power to provide electricity to six US homes for an entire year and avoids emissions of 46 Metric Tons of CO<sub>2</sub>.

Red Horse engineers are currently evaluating the installation, demonstration and testing of a 500 KW Wind Turbine (\$1.55 million) and all associated impacts/studies as a potential phase four of the project. This award is presented to the organizational maintenance shop in each state that achieves the highest degree of efficiency during the training year in maintenance of material and maintenance management.

In winning the award, the FMS 17 team met or exceeded the following criteria:

1. Demonstrated efficiency in maintenance operations and maintenance management procedures.
2. Showed that they assisted their supported units in obtaining a high state of readiness as evidenced by readiness reports, semi-annual SMM visits, COMETS, and CLRT-X visits.

3. Met all guidelines based on Ohio NGB goals and priorities to enhance readiness.
4. Demonstrated a high regard for environmental matters by adhering to all environmental rules and regulations.

### **This Week in Guard History.**

Dec. 7, 1747: Philadelphia, Pa. The Associated Regiment of Foot, ancestor of today's 111th Infantry, first parades under arms in front of the Philadelphia Court House. There they divide themselves into 11 companies by ward or township. They elect company and regimental officers, who are commissioned by the governor.

Each member carries his own privately purchased musket, sword and cartridge box. Local women design and fund the fabrication of company flags. The Associated Regiment of Foot is a privately organized and equipped, all-volunteer force acting as a public defense force with the consent of the governor and assembly. Due to Quaker control of the legislature, Pennsylvania has no governmentally organized militia. That would not change until 1777, two years after the start of the Revolutionary War.

### **Recent News Releases**

**Admiral Mullen: 16,000 troops have orders to Afghan war**, Associated Press, Friday Dec 11, 2009. The Pentagon's top military officer says 16,000 troops have received their orders for Afghanistan since President Barack Obama announced his new war strategy. Adm. Mike Mullen said at a news conference Thursday that the first to go, a battalion of Marines, will arrive in southern Afghanistan next week. The Joint Chiefs of Staff chairman said tens of thousands of tons of construction materials, winter gear and other equipment also are in the pipeline. Officials are moving to get the bulk of the 30,000 additional troops into the war zone by summer.

**Tax Statements Coming Next Week on myPay.** Annual tax statements soon will be distributed to service members, military retirees, annuitants and federal civilian employees who are paid by the Defense Finance and Accounting Service, but they will be available electronically up to two weeks earlier to DFAS customers with myPay accounts. The first W-2s, 1099Rs and 1099-INTs, along with retiree and annuitant annual account statements, will start becoming available on Dec. 16, DFAS says. The first wave of forms: Retiree Annual Statements and Retiree 1009R forms will be mailed that day.

W-2s for active-duty members of the Army, Navy and Air Force will go out from Jan. 23 through Jan. 29, but all will be available on myPay starting on Jan. 20. W-2s for reserve component members in those three services will be mailed from Jan. 4-7 and can be accessed starting on Jan. 4. Certain forms, including W-2s for VSI/SSB recipients, Vendor Pay 1099s, Vendor Pay MISC W-2s and Civilian PCS W-2s, will not be available on myPay, DFAS says. **VA Reaching Out to 'Touch' Guardsmen.** The Department of Veterans Affairs is reaching out to "touch" deployed National Guardsmen and Reservists at least seven times during a deployment cycle. Called the "Seven Touches of Outreach," the VA program wants to "engage Guard and Reserve veterans at least seven times during the deployment cycle with targeted messages and face-to-face encounters with VA staff members," VA Secretary Eric K. Shinseki told the Guard's Joint Leadership Conference held recently in Washington, D.C.

"With this generation, a letter in the mail doesn't cut it anymore," he said. "There has to be personal contact for the message to get across." Those engagements start when service members arrive at the demobilization site from theater." They receive an overview on VA services and benefits and are enrolled in VA health care," the secretary said. "Members are assigned an (Operation Enduring Freedom/Operation Iraqi Freedom) program manager to contact, who will set up their initial health and dental appointments at the VA facility of their choice." And during that demobilization process, service members are required to fill out the Post-Deployment Health Reassessment, meet with a health care provider and self-evaluate their health status as compared to how it was prior to the deployment. Additionally, the VA sends representatives to reintegration programs like the Yellow Ribbon and contacts veterans through the Combat Veteran Call Center to advise them of benefits and services.
