4. Old Business

A. Partnership Recorder – Reagan

B. Energy Update - Giezie

Briefed at every meeting. Slides not available for meeting. Smart meters will let us see what the base is doing. Will be tied to the LAN so that CE can tell what is going on with the buildings at all times. Waiting on Toledo Edison – parts needed. Energy usage looking good. **OPEN ITEM.**

C. IBB - Reagan

Open item from 01 Jan 08. IBB held and work schedule change request policy was created. Item now closed.

D. LPC Review - Reagan

Open item from 09 Oct 07. LPC has to review all policies that were on the intranet to make sure they are current (there were some that were rescinded and still posted as current). Status – Dohrman got his answers. Item now closed.
