**PARTNERSHIP MEETING MINUTES**

MEETING began at 0930 on 14 October 2009: attendees were Stuart Driesbach, Brad Anspaugh, Ben Emch, Bob Ketchum, Joe Donohue, and Rita Schmitt

**1. OLD BUSINESS:**

**a. Running Track – OPEN**

This issue is at the ARPEC level, waiting on availability of funds.

**b. Repainting floor/yellow stripes – OPEN**

Gabe Denner can get the paint. There should be a template on the stripes. We'll try to rent a striper machine.

**c. Sealing the Ramp – OPEN**

Management spoke with BG Lee about sealing the ramp, Bob Ketchum brought up the fact that there is an area back by supply where the roofers had parked that also needs work done on it.

**d. Workout Equipment – OPEN**

Management previously requested to see if ACOE money is available for new equipment.

**2. NEW BUSINESS:**

**a. Installation of Lights – OPEN**

More lights are being installed because the original amount didn't make enough light in the hangar to see properly.

**b. Electric Cables – OPEN**

Ben Emch is working on ordering electric cables to be used in the old reels and adjusted for use.

**c. Hangar Doors – OPEN**

Mel Baez is wait on a call back from Megadoor to see when they can come and check the operation of all the hangar doors and check the boxes where the switches are located.

**d. Job Announcements – OPEN**

Management explained that the current postings are for two-Aircraft Mechanics (WG-12's) and the Aircraft Mechanic Supervisor (WS-09). He was informed that it would be permissible to have the hiring team in Iraq, since that is where nearly all of our mechanics are located at this time. He will meet with Labor to go over the particulars of the Flight Engineer's job, prior to a request for that announcement being sent to HRO. Management also informed the members that the Flight Supervisor position and the Maintenance Supervisor position will not be posted until the 1-137<sup>th</sup> Aviation Regiment returns from Iraq (we must wait until the Mech Supv is hired so we can be sure rank inversion doesn't occur).

**e. Presidential Executive Order on Text Messaging – OPEN**

Section 7902(c) of title 5, United States Code, and the Federal Property and Administrative Services Act of 1949, as amended, 40 U.S.C. 101 et seq." Management wanted everyone to be informed of the above mentioned order, which states, "Sec. 2. Text Messaging While Driving by Federal Employees.

Federal employees shall not engage in text messaging (a) when driving GOV, or when driving POV while on official Government business, or (b) when using electronic equipment supplied by the Government while driving.” If you need more explicit information you can look up this section on the internet.

f. CFC – OPEN
