SUBJECT: 2022 Camp James A. Garfield Controlled Military Deer Hunt Application

- Camp James A. Garfield (C-JAG) is now accepting applications for the 2022 Controlled Deer Hunt Military Drawing. Current members of the active and reserve components of the Army, Navy, Air Force, Space Force, Marines, and Coast Guard and Armed Forces Retirees are qualified to apply to the C-JAG Controlled Deer Hunt Drawing. This also includes M-Day or traditional guardsmen and reservists.
- **Applying to the C-JAG Military Deer Hunts does not guarantee a hunt date. Applications are selected by a random drawing. Thirty-nine (39) applications are selected for each hunt. C-JAG receives hundreds of hunt applications each year and cannot guarantee that all applicants will be selected.**
- Please read and follow the instructions below when completing an application for the C-JAG Military Deer Hunts. **Failure to follow any of the stated instructions while applying for the deer hunts may result in disqualification from the drawing.**
- This is a partner hunt. Each qualified military applicant must apply with another qualified military applicant, military dependent, or a civilian partner who is a U.S. citizen. Only one vehicle per pair will be permitted in the field, so partners should plan to travel together in a single vehicle. All hunts are shotgun only (10, 12, 16, 20, 28, and .410 gauge). No handguns, rifles, muzzle-loading firearms, longbows or crossbows may be used or brought to the hunts.
- Applicants who apply for the C-JAG military deer hunt drawing may not apply through the Ohio Division of Wildlife civilian drawing for the C-JAG Controlled Deer Hunt. This does not prohibit you from applying to other Ohio Division of Wildlife controlled deer hunts.
- **The only controlled hunt date for 2022 is scheduled for 12 November.** This year's only hunt will be a 50/50 either sex hunt. During the 50/50 hunt, one partner will receive an either sex permit and the other partner will receive an antlerless only permit. If you know which partner is to receive the either sex permit, please indicate that in the appropriate section on the application.
- Send **ONLY ONE** application per hunt pair by mail with two (2) #10 size (4 1/8" × 9 1/2") self-addressed, stamped envelopes (one envelope for each hunter in pair regardless of residency). Multiple applications FROM the same individual WILL BE DISCARDED. Multiple applications in the same envelope will also be discarded. Facsimile (fax), email, and roster-type applications will not be accepted. Applications are due at C-JAG Environmental Office by close of business on **Friday, 12 August 2022**. Selected applicants will be notified by email not later 2 September 2022. If you do not receive an electronic notification or phone call from the C-JAG Environmental Office by 2 September, know that you have not been drawn for this year's hunt. **Do not call before 2 September to ask if**

your application was selected. Paperwork for winning applicants will be mailed out no later than the week of 3 October 2022. **Military drawing results WILL NOT be posted on the Ohio Division of Wildlife website.**

- To apply for the C-JAG military drawing, complete the enclosed application and return it in accordance with the guidance found on the application. Hunt areas will be randomly assigned by C-JAG.
- In order to hunt, the primary military hunter will be required to show a current military ID on the selected hunt date during registration. Secondary hunters will be required to show military ID, dependent ID card, or driver's license. Secondary hunters under the age of 18 will not be required to provide an ID card. Each hunter will be required to pay a \$5.00 (**cash only**) hunt administration fee at the registration table on the day of the hunt. DO NOT send money or any form of PII with your application.
- Military hunt permits are **NOT** transferable. If the second hunter can not attend, the primary hunter may attend alone, or may contact C-JAG at 614-336-4564 prior to 30 September 2022 to identify a different partner. After 30 September 2022, partner changes will not be made. If the primary hunter can not attend, neither hunter may attend.
- Hunts are subject to cancellation at any time due to heightened FPCON, mission requirement conflicts, public health, and/or safety concerns. Should such a cancellation occur, hunters will be notified via email as soon as possible by either the C-JAG Environmental Office.
