# BATTERY C, 1ST BATTALION, 134TH FIELD ARTILLERY REGIMENT



Battery C, 1st Battalion, 134th Field Artillery Regiment was organized on July 18, 1877 in Marysville, Ohio as Company E, 14th Infantry Regiment. The company adopted the local designation of Curry Cadets, in honor of their first commanding officer, Capt. William L. Curry (left) who was a native of Union County and served in the 1st Ohio Volunteer Cavalry during the Civil War.

During the War with Spain the unit, now Company D, fought in Puerto Rico, taking part in the battle near Guayama on Aug. 5, 1898. The unit returned to Marysville in 1899 and was redesignated as Company E, 4th Infantry Regiment and served along the Mexican Border in 1916-17. Maj. Gen. Robert S. Beightler, future 37th Infantry Division commander, enlisted in the company in 1911 and was commissioned a second lieutenant in 1914. During World War I, the company was part of the 166th Infantry, 42d "Rainbow" Division, taking part in numerous campaigns in 1918.

During World War II, Company E was ordered into active service in October 1940 and trained at Camp Shelby, Miss. In 1942, the 166th Infantry was relieved from assignment to the 37th Division and remained in the United States as a training regiment. The unit reorganized in Marysville in 1947 as Anti-Tank and later Tank Company, 166th Infantry. In 1959, the unit was converted to Battery B, 1st Howitzer Battalion, 134th Artillery and returned to the 37th Infantry Division.

The unit remained field artillery until converting back to infantry in 1972 as a detachment of Company B, 1st Battalion, 166th Infantry stationed in Delaware. On Sept. 1, 1992, the Doellinger Armory in Marysville was closed and the detachment was consolidated with Company B (organized Jan. 17, 1947 in Delaware) and Headquarters and Headquarters Company, 1st Battalion, 166th Infantry (organized July 5, 1928 in Columbus). The consolidated units were designated as Detachment 1, Company C, 1st Battalion, 148th Infantry and stationed in Delaware, with the parent company stationed in Bellefontaine.

On Sept. 1, 2001, the detachment was consolidated with Company C (organized May 2, 1929 in Bellefontaine) in Delaware. On Oct. 6, 2001, the 1st Battalion, 148th Infantry was the first unit in the Ohio Army National Guard ordered into federal service for the War on Terrorism. Company C was broken into three task forces that guarded Rock Island Arsenal, Ill.; Lima Army Tank Plant, Ohio; and Ravenna Training and Logistics Site, Ohio.

Due to a statewide reorganization, Company C was converted to the 585th Military Police Company on Sept. 1, 2007. A year later the Delaware Armory was closed and the unit returned home to the new Marysville Training and Community Center. The 585th served in Iraq in 2009-2010, where it earned the Meritorious Unit Commendation as an element of the 49th Military Police Brigade.

On Sept. 1, 2018 the company returned to the field artillery branch when the unit was reorganized as Battery C, 1st Battalion, 134th Field Artillery Regiment and was assigned to the 37th Infantry Brigade Combat Team. The battery was fielded the new M777 155 mm howitzers as part of the reorganization. The battery returned to active service on Sept. 23, 2022 and was deployed in support of Combined Joint Task Force - Operation Inherent Resolve.

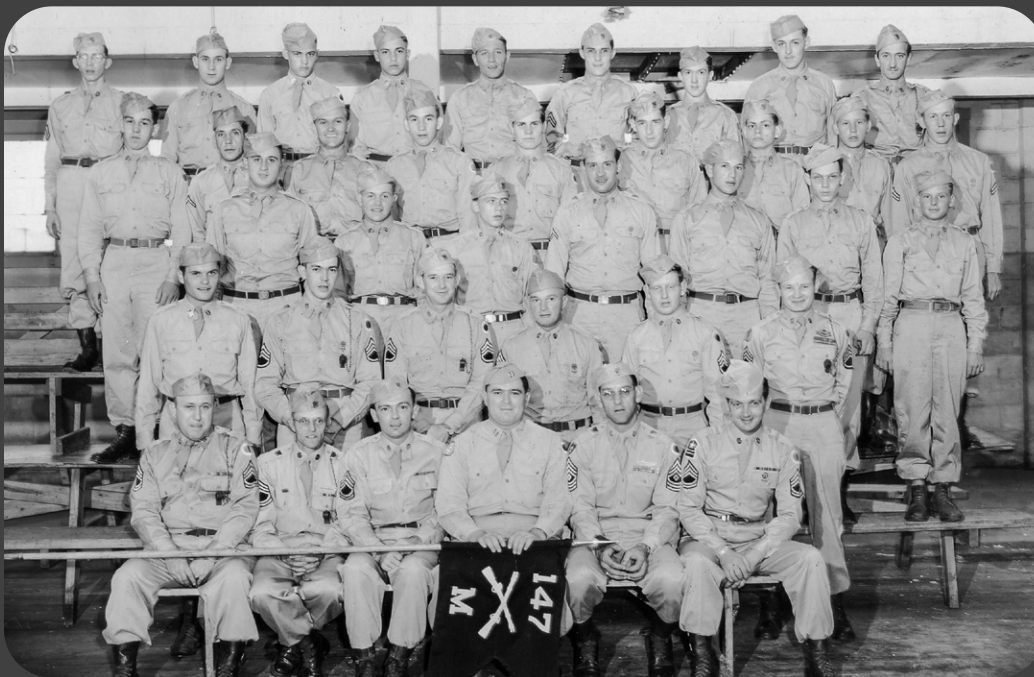

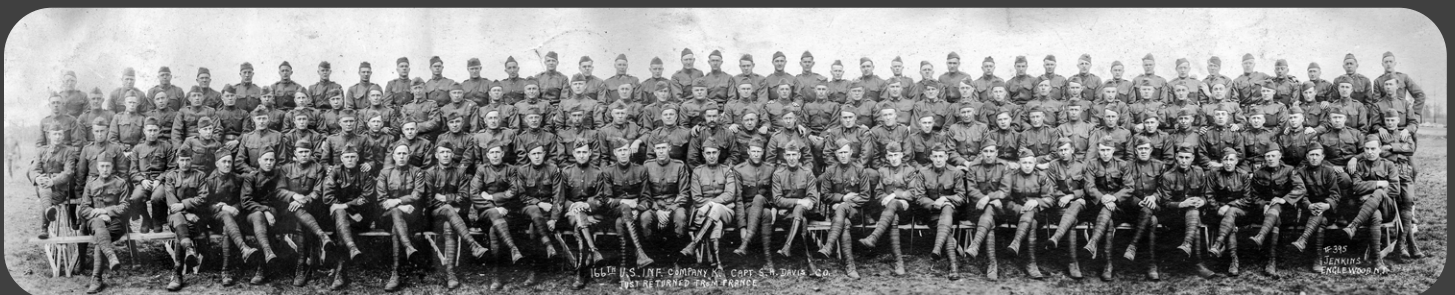

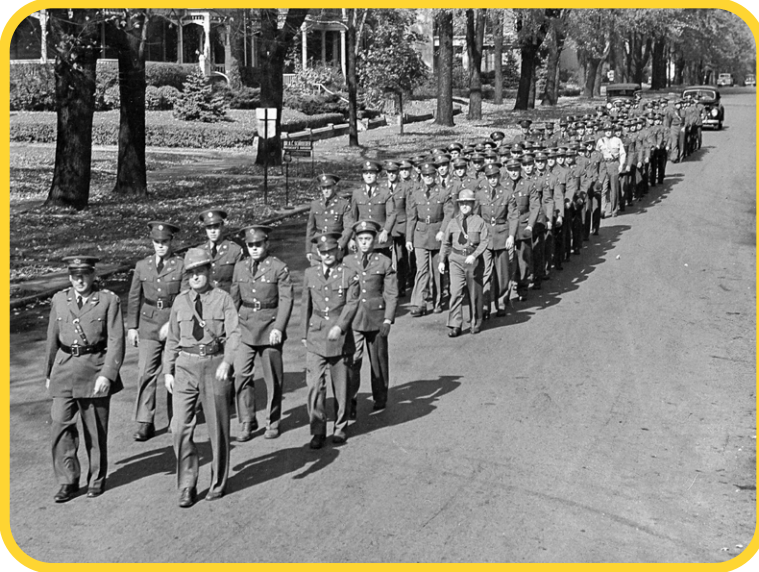

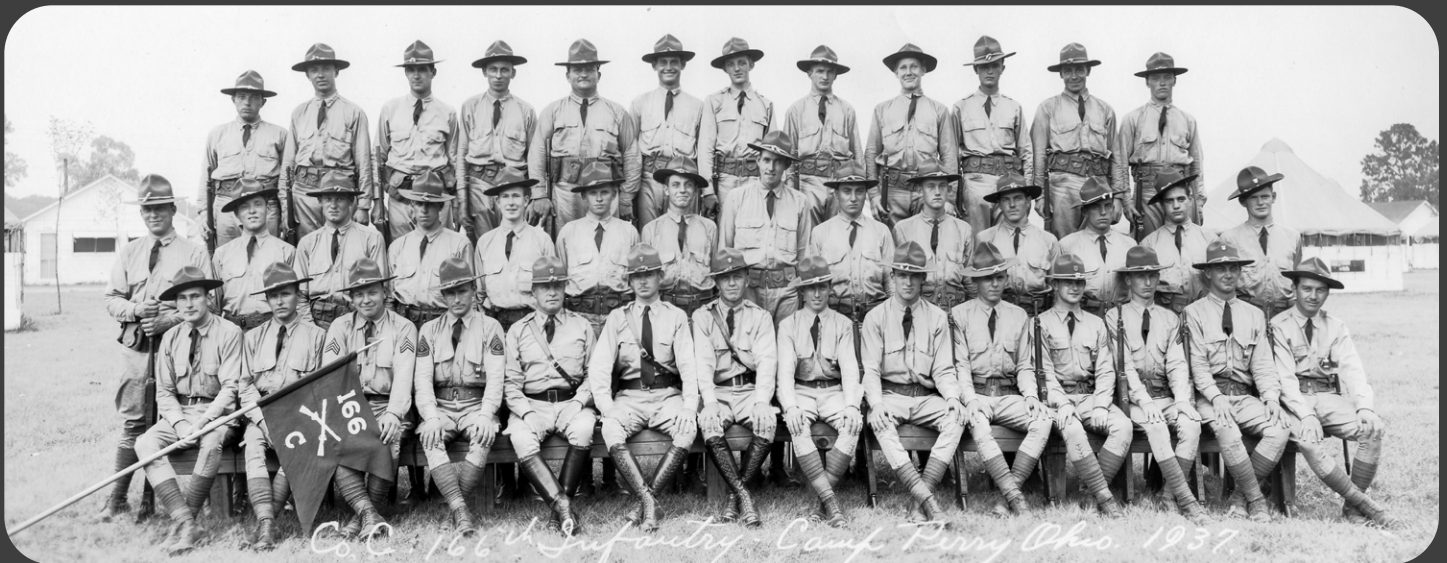

# HERALDIC ITEMS



## DISTINCTIVE UNIT INSIGNIA

Description/Blazon: A Gold color metal and enamel device 1 1/8 inches (2.86 cm) in height overall, consisting of a shield blazoned: Gules, on the dexter arm of a saltire Azure fimbriated Or three alerions bendwise Argent. Attached below the shield a Gold scroll inscribed "FIDES ET AUDAX" in Blue.

Symbolism: The red shield indicates the original allocation of the unit as Artillery. The blue saltire is representative of Civil War Service with the Union forces. The three alerions, taken from the arms of Lorraine, denote World War I service.

Background: The distinctive unit insignia was originally approved for the 134th Field Artillery Regiment, Ohio National Guard on 10 February 1930. It was amended to change the design and blazon of the shield on 2 January 1934. It was redesignated for the 134th Field Artillery Battalion, Ohio National Guard on 23 November 1944. It was redesignated for the 174th Field Artillery Battalion, Ohio National Guard on 19 March 1951. The insignia was redesignated for the 134th Artillery Regiment, Ohio National Guard on 23 November 1960. It was redesignated for the 134th Field Artillery Regiment effective 2 September 1993, with the description and symbolism revised.



## COAT OF ARMS

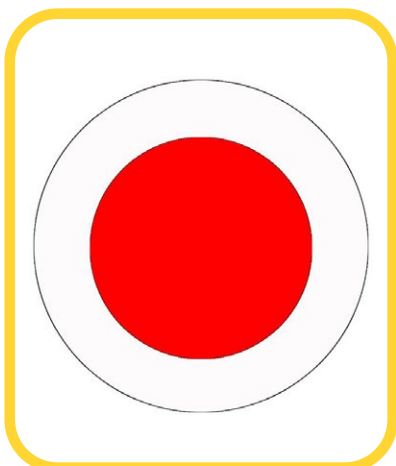
Description/Blazon:

Shield: Gules, on the dexter arm of a saltire Azure fimbriated Or three alerions bendwise Argent. Crest: That for the regiments and separate battalions of the Ohio Army National Guard: From a wreath Or and Gules, a sheaf of seventeen arrows Argent bound by a sprig of buckeye (Aesculus glabra) fructed Proper (two leaves with bursting burr).

Motto: FIDES ET AUDAX (Faithful and Bold).

Symbolism: The red shield indicates the original allocation of the unit as Artillery. The blue saltire is representative of Civil War Service with the Union forces. The three alerions, taken from the arms of Lorraine, denote World War I service.

Background: The coat of arms was originally approved for the 134th Field Artillery Regiment, Ohio National Guard on 7 February 1930. It was amended to change the design and blazon of the shield on 2 January 1934. It was redesignated for the 134th Field Artillery Battalion, Ohio National Guard on 22 November 1944. It was redesignated for the 174th Field Artillery Battalion, Ohio National Guard on 19 March 1951. The insignia was redesignated for the 134th Artillery Regiment, Ohio National Guard on 23 November 1960. It was redesignated for the 134th Field Artillery Regiment effective 2 September 1993, with the description and symbolism revised.



## SHOULDER SLEEVE INSIGNIA

Description/Blazon: On a white disc 2 1/4 inches (5.72 cm) in diameter a red disc 1 1/2 inches (3.81 cm) in diameter.

Symbolism: The red and white disc is taken from the State Flag of Ohio.

Background: The shoulder sleeve insignia was originally approved for the 37th Division on 5 November 1918. It was redesignated for the 16th Engineer Brigade on 9 July 1968. It was canceled on 4 December 1969. The insignia was reinstated and redesignated effective 1 September 2007, for the 37th Infantry Brigade Combat Team, with the description updated and a symbolism added.
