- 1920** Organized and Federally recognized 21 June 1920 in the Ohio National Guard at Port Clinton as Company H, Tank Corps¹³
- 1921** Redesignated 1 July 1921 as the 37th Tank Company, an element of the 37th Division¹⁴
- 1940** Redesignated 1 September 1940 as Company C, 192d Tank Battalion¹⁵
Relieved 15 October 1940 from assignment to the 37th Division
Inducted into Federal Service 25 November 1940 at Port Clinton¹⁶
- 1942** Surrendered to Japanese Forces 9 April 1942 on Bataan Peninsula, Philippine Islands
- 1946** Inactivated 2 April 1946
- 1948** Reorganized and Federally recognized 26 October 1948 in the Ohio Army National Guard at Port Clinton as the 1428th Engineer Treadway Bridge Company¹⁷
- 1950** Ordered into active Federal service 11 September 1950 at Port Clinton
- 1952** Redesignated 23 January 1952 as the 1428th Engineer Float Bridge Company
- 1953** Redesignated 1 December 1953 as the 1428th Engineer Company
- 1954** (112th Ordnance Company [NGUS] organized and Federally recognized 4 January 1954; Federal recognition withdrawn 1 December 1954 from the 112th Ordnance Company [NGUS])¹⁸
- 1955** 1428th Engineer Company released from active Federal service 28 January 1955 and reverted to state control; unit designated as the 112th Ordnance Company
- 1959** Consolidated 1 September 1959 with Headquarters and Headquarters Company, 112th Transportation Battalion (see ANNEX 1); consolidated unit designated as the 3641st Ordnance Company¹⁹
- 1963** Reorganized and redesignated 1 April 1963 as the 112th Ordnance Company²⁰
- 1968** Reorganized and redesignated 15 February 1968 as the 212th Light Equipment Maintenance Company²¹

- 1972** Reorganized and redesignated 1 February 1972 as the 213th Heavy Equipment Maintenance Company²²
- 1981** Consolidated 1 November 1981 with Detachment 1, 213th Maintenance Company (see ANNEX 2); consolidated unit designated as the 213th Maintenance Company²³
- 2001** Consolidated 30 September 2001 with the 212th Ordnance Company (organized and Federally recognized 10 September 2000 at Port Clinton) and Detachment 1, 213th Maintenance Company (organized and Federally recognized 3 December 1999 at Walbridge); consolidated unit designated as the 213th Ordnance Company²⁴
- 2007** Consolidated 1 September 2007 with Detachment 1, 372d Maintenance Company (organized and Federally recognized 10 September 2000 at Port Clinton); consolidated unit designated as Company D, 1st Battalion, 148th Infantry Regiment, an element of the 37th Infantry Brigade Combat Team; location concurrently changed to Sandusky²⁵
- 2008** Ordered into active Federal service 2 January 2008 at Sandusky; released from active Federal service 9 January 2009 and reverted to state control²⁶
- 2011** Ordered into active Federal service 11 September 2011 at Sandusky; released from active Federal service 14 October 2012 and reverted to state control²⁷

- 1922** Organized and Federally recognized 23 March 1922 as Headquarters Company, 1st Battalion, 148th Infantry at Clyde, an element of the 37th Division³⁰
- 1940** Reorganized and redesignated 1 May 1940 as Headquarters Detachment, 1st Battalion, 148th Infantry³¹
- Inducted into Federal service 15 October 1940 at Clyde³²
- 1942** (37th Division redesignated 1 February 1942 as the 37th Infantry Division)³³
- Reorganized and redesignated 1 December 1942 as Headquarters Company, 1st Battalion, 148th Infantry³⁴
- 1945** Inactivated 5 December 1945 at Camp Anza, California³⁵
- 1948** Reorganized and Federally recognized 3 March 1948 in the Ohio Army National Guard at Clyde as Service Battery, 135th Field Artillery Battalion³⁶
- 1952** Ordered into active Federal service 15 January 1952 at Clyde³⁷
- 1954** (Service Battery, 140th Field Artillery Battalion [NGUS] organized and Federally recognized 22 January 1954)³⁸
- Released from active Federal service 15 June 1954 and reverted to state control; Federal recognition concurrently withdrawn from Service Battery, 140th Field Artillery Battalion (NGUS)³⁹
- 1959** Converted and redesignated 1 September 1959 as Troop K, 3d Squadron, 107th Armored Cavalry and relieved from assignment to the 37th Infantry Division⁴⁰
