COMPANY H, 134TH SUPPORT BATTALION

Company H, 134th Support Battalion was organized in the Ohio National Guard on November 18, 1921 in Akron, Ohio as Troop I, 1st Cavalry, under the command of Capt. C.P. Firestone. In 1922, the troop was redesignated as Troop E, 107th Cavalry. In October 1927, the troop was reorganized as Headquarters Troop, 54th Cavalry Brigade, which was an element of the National Guard's 22d Cavalry Division. On November 1, 1940 the brigade was removed from the force structure and the headquarters troop was disbanded.

The unit was reorganized in Akron following World War II on March 16, 1948 as Troop E, 107th Cavalry Reconnaissance Squadron. When the 107th became a armored cavalry regiment, Troop E was reorganized as the Assault Gun Company, 1st Battalion. In 1951, those companies were redesignated as Howitzer Company.

In 1959, the company was reorganized as Troop F, 2d Squadron, 107th Armored Cavalry, followed by a change of station from Akron to Greensburg in 1961. In 1963 the unit was redesignated as Troop H, which became Company H in 1965. In 1969, the company was consolidated with the 2d Squadron Headquarters Troop, which was first organized in Akron in 1947.

On June 1, 1974, the Headquarters Troop was redesignated as Troop G, 2d Squadron and in August 1976, the unit moved to Alliance, Ohio and was the first unit in the new armory there. On May 1, 1977 the troop was reorganized as Howitzer Battery, 2d Squadron, 107th Armored Cavalry and remained unchanged for the next 15 years.

On September 2, 1993, the battery was consolidated with the 3d Squadron's Howitzer Battery to form Battery B, 1st Battalion, 134th Field Artillery. It was first assigned to the 28th Infantry Division, before changing to the 38th Infantry Division a year later.

In 2004, the battery was ordered into active service and mobilized with the battalion as part of Task Force Reaper Sentinel. The unit was tasked with conducting security, force protection, and anti-terrorism operations at various United States Air Force Europe and United States Army Europe facilities in Europe.

On September 1, 2007, the battery was converted to Company F, 128th Support Battalion, which served as the forward support company for the 1st Battalion, 145th Armored Regiment. The following March, the battalion was converted to a separate battalion and Company F was redesignated as the 737th Support Company and moved from Alliance to Stow.

In 2016 the company was assigned to the 1st Brigade Combat Team, 34th Infantry Division and was redesignated on September 1, 2018 under its present designation. From 2019 to 2020, the company was mobilized to United States Central Command's area of operation in support of Operations Enduring Freedom, Inherent Resolve, and Spartan Shield, where it was awarded the Meritorious Unit Commendation.

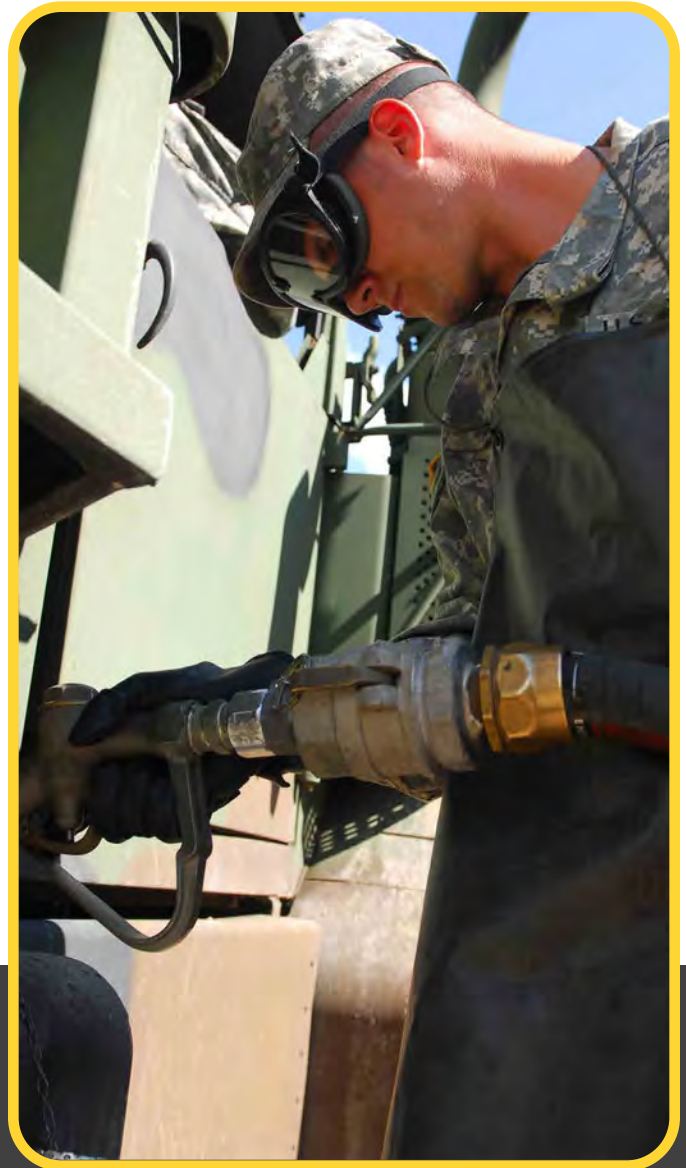

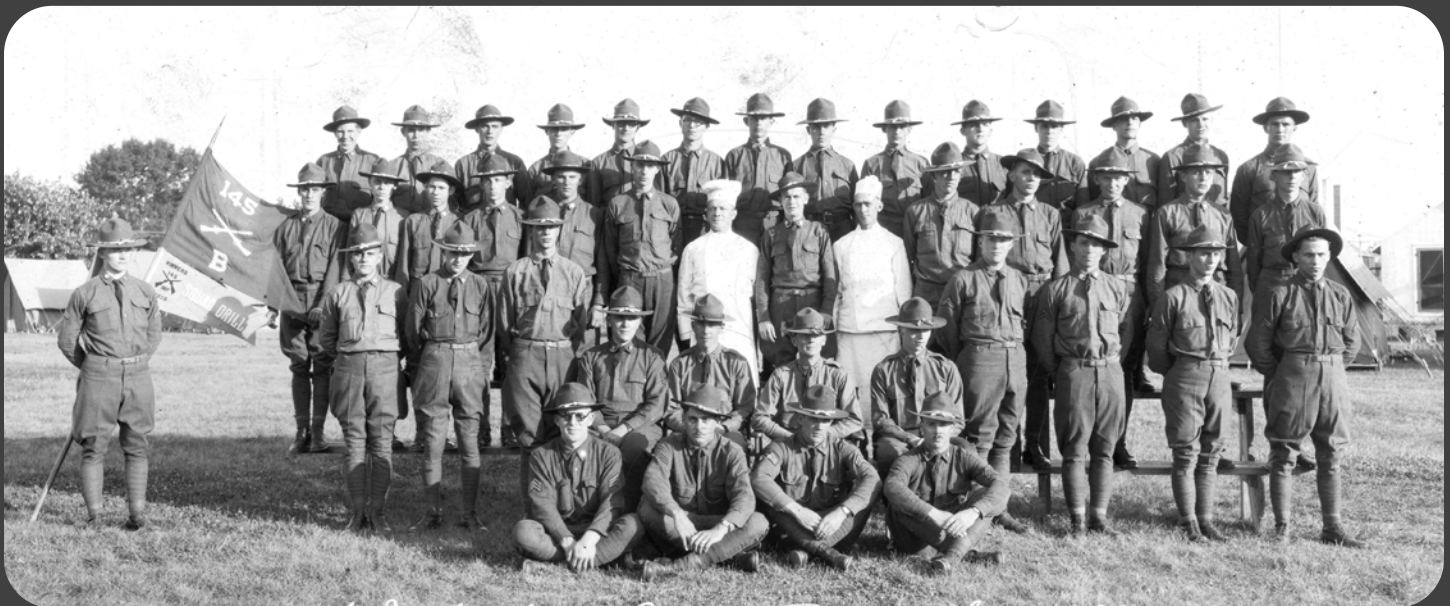

HERALDIC ITEMS



DISTINCTIVE UNIT INSIGNIA

Description/Blazon: A Gold color metal and enamel device 1 1/8 inches (2.86 cm) in height overall consisting of a shield blazoned: Per bend wavy Or and Brick Red, a bend wavy counterchanged between a fleur-de-lis of the second and a crescent of the first, on a canton Azure a cornucopia Gold. Attached below the shield a Gold scroll inscribed "ADSIDUE SUPPLERE" in Blue letters.

Symbolism: Brick red is a color traditionally associated with Supply and Transportation, former designation of the unit. The cornucopia is taken from the coat of arms of the 109th Quartermaster Regiment, parent organization of the Battalion. The crescent represents Tunisia and refers to the first campaign in which the unit participated during World War II. The two wavy bands allude to the Rhine and Arno Rivers and with the fleur-de-lis, refer to the Battalion's war service in Germany, Italy, and France. The motto translates to "To Supply Continuously."

Background: The distinctive unit insignia was originally approved for the 47th Supply and Transport Battalion on 27 May 1964. It was redesignated for the 134th Supply and Transportation Battalion on 10 April 1991. The insignia was redesignated for the 134th Support Battalion on 11 December 1996.



COAT OF ARMS

Description/Blazon

Shield: Per bend wavy Or and Brick Red, a bend wavy counterchanged between a fleur-de-lis of the second and a crescent of the first, on a canton Azure a cornucopia Gold.

Crest: That for the regiments and separate battalions of the Minnesota Army National Guard: From a wreath Or and Brick Red, a sheaf of wheat Proper.

Motto: ADSIDUE SUPPLERE (To Supply Continuously).

Symbolism

Shield: Brick red is a color traditionally associated with Supply and Transportation, former designation of the unit. The cornucopia is taken from the coat of arms of the 109th Quartermaster Regiment, parent organization of the Battalion. The crescent represents Tunisia and refers to the first campaign in which the unit participated during World War II. The two wavy bands allude to the Rhine and Arno Rivers and with the fleur-de-lis, refer to the Battalion's war service in Germany, Italy, and France.

Crest: The crest is that of the Minnesota Army National Guard.

Background: The coat of arms was originally approved for the 47th Supply and Transport Battalion on 27 May 1964. It was redesignated for the 134th Supply and Transportation Battalion on 10 April 1991. The insignia was redesignated for the 134th Support Battalion on 11 December 1996.



SHOULDER SLEEVE INSIGNIA

Description/Blazon: On a black olla with a 1/8 inch (.32 cm) black border, 2 inches (5.08 cm) in width and 2 1/4 inches (5.72 cm) in height, a red bull skull.

Symbolism: The patch shape simulates an olla (Mexican water flask) symbolizing the 34th Division's origin, formation and intensive training site at Camp Cody, New Mexico in Oct 1917. The bull skull also symbolizes the surrounding dry, desert-like area. Black denotes durability, firmness and stability and red is for courage and action.

Background: The shoulder sleeve insignia was originally approved for the 34th Division on 28 June 1922. It was redesignated for the 34th Command Headquarters (Divisional), Iowa National Guard on 16 October 1963. The insignia was redesignated for the 34th Infantry Division effective 10 February 1991, and amended to add a border and provide a symbolism for the design.
