Legislation of Interest

HR. 270, introduced by Congressman Bob Latta of Ohio's fifth Congressional district, and S. 731, introduced by Senator Ben Nelson (NE) are the companion bills addressing the gray area TRICARE issue.

Gray area retirees are members of the National Guard and Reserves who have retired from service after a minimum of 20 years who are not yet 60 years old. Under current law, those retired members and their families are not eligible to purchase TRICARE Reserve Select until they reach the age of 60. There are House and Senate companion bills that would permit these gray area retirees to purchase TRICARE Reserve Select. This is budget neutral as the retirees would pay a premium equal to the full cost of coverage.

President Obama Offers Plan to Improve Care for Veterans [The New York Times, April 10, 2009, Pg. 16] Barack Obama announced plans to computerize the medical records of veterans into a unified system, a move that is expected to ease the now-cumbersome process that results in confusion, lost records and bureaucratic delays.

Military Budget Reflects a Shift In U.S. Strategy [The New York Times, April 7, 2009, Pg. 1] Secretary Gates announced a major reshaping of DoD's budget on Monday, with deep cuts in many traditional weapons systems but new billions of dollars for others, along with more troops and new technology to fight the insurgencies in Iraq and Afghanistan.

Congressman wants Troops to Teachers expanded. U.S. Rep. Tom Petri of Wisconsin is pushing legislation to make more schools eligible for a program that recruits veterans as teachers. The Troops to Teachers program has placed more than 11,500 veterans in American schools since it started in 1994. The program gives veterans a \$5,000 stipend to help them obtain teaching certification in return for three years of teaching in a "high-need" school.

Fight Over F-22's Future to Test Defense Overhaul. [The Wall Street Journal, April 8, 2009, Pg. 5] The highest-profile test of Secretary Gates' plan to overhaul how the Pentagon buys weapons will be whether he succeeds in winding down

production of the F-22 Raptor — the most advanced fighter the Air Force has ever flown.

Taliban Threat Growing. [CNN, April 7, 2009]Adm. Mike Mullen said the Afghan insurgency has grown dramatically over the last year, and with warmer weather coming, we can expect the fighting to pick up considerably.

Biden Warns Israel Against Striking Iran. [Los Angeles Times, April 8, 2009, Pg. 20]. The vice president tells CNN that Netanyahu would be 'ill advised' to try to attack nuclear sites. Joe Biden issued a high-level admonishment to Israel's new government Tuesday that it would be "ill advised" to launch a military strike against Iran.

N. Korea Envoy Warns U.N. Against Retaliating. [Los Angeles Times, April 8, 2009, Pg. 19] A senior North Korean diplomat warned Tuesday that his government will retaliate if the U.N. Security Council takes action over it rocket launch, insisting that Pyongyang sent up a peaceful satellite and not a missile.

Cyber Attacks Are Costly For Pentagon [Los Angeles Times, April 8, 2009, Pg. 14]. In six months it has spent \$100 million to fix military networks. The Pentagon spent more than \$100 million in the last six months responding to and repairing damage from cyber attacks and other computer network problems.

Omnibus Veterans' Benefits Bill.

U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs
Committee, recently introduced the Veterans' Insurance and Benefits
Enhancement Act of 2009, which addresses a broad range of veterans' benefits.
Insurance enhancements in the bill include:

- A new insurance program for service-connected disabled veterans;
- An expanded eligibility for retroactive benefits from traumatic injury protection coverage; and
- A \$10,000 increase to the amount of supplemental insurance totally disabled veterans may purchase. * I found this to be extremely interesting. This bill would increase the maximum amount of Veterans' Mortgage Life Insurance that a service-connected disabled veteran may purchase from the current maximum of \$90,000 up to \$200,000. In the event of the veteran's death, the veteran's family is protected because VA will pay the balance of the mortgage owed up to the maximum amount of insurance purchased. The need for this increase is obvious in today's housing market.
