Army Guard's New Recruiting Campaign Debuts. A theater in downtown Washington, D.C., was the site last week for the debut of the Army National Guard's new recruiting campaign, which is set to launch today. Dubbed "At This Moment", the campaign uses significant moments in a person's life, such as high school graduation, as well as those of national or historical significance to showcase the role of the Army Guard and what it offers to potential recruits.

The centerpiece of the campaign is a mini-movie that showcases Guard soldiers performing a variety of roles and missions. Shot over a two-month period in more than 35 states and featuring real Guard soldiers, the video piece features high-end production and cinematography that gives it the look and feel of a movie, said Walls. It is scheduled to be shown in more than 950 theaters across the country and will also be featured on YouTube, Facebook, and other social media Web sites. The print advertisements will get a makeover, as well. "The look and feel of the Army National Guard [print ads] has moved away from the old, drab presentation that we've had," said Lt. Col. Ron Walls, chief of the recruiting and retention division for the ARNG, adding that the changes will give them a sense of energy and vibrancy.

ONG Moving Billboards. While driving down the highways and byways in Ohio these days, you may start seeing some moving billboards for the Ohio National Guard. Five USP&FO trailers earmarked for "Buckeye Express" deliveries across the state are receiving a fresh look with images of National Guard Soldiers on their sides and back. With our vision statement, "When Called, We Respond with Ready Units," stretched across the sides of trailers, each side features professionally shot images of National Guard Citizen-Soldiers at work. Whether it's urban warfare training, humanitarian relief efforts, or basic combat training, drivers by will get a powerful visual of the community, state and national missions answered by the Ohio National Guard. To date, three 30-foot trailers have been wrapped, and two additional trailers (48-foot and 28-foot) will be wrapped in January 2010. These trailers make a nice complement to the more than 50 wrapped Recruiting and Retention vehicles which are already on the road.

NGAUS Update on the TRICARE for Life Rate Hike Concern. A large number of alumni have raised questions about the status of TRICARE for Life potential rate increases. The following update was provided by the National Guard Association of the United States on November 6:

Many of our members have received an e-mail that has been in circulation for almost a year that raises concerns about a Congressional Budget Office (CBO) potential cost-saving recommendation prepared last year. The recommendation suggested that TRICARE for Life (TFL) beneficiaries pay prohibitive co-pays of the first \$525 in medical costs, increasing to \$2,999 per person. There is nothing being actively considered in Congress regarding the subject CBO recommendation. Moreover, the President's budget, for the first time in four years, did not include any proposals for a TRICARE fee hike. Congress has not approved any TRICARE fee hike in the past when fee increases were recommended by the President's budget. That being said, what may emerge as the final health care bill is yet to be determined. NGAUS, along with other service member related organizations in Washington, will closely monitor any attempt by Congress to increase TFL co-pay rates or other fees. We all must be vigilant and ready to act if that time may come.

Ohio Veteran Bonus Update. The Ohio Department of Veterans Services (DVS) is diligently creating an application process so that veterans can request the bonus that was approved for them by voters on election day, November 3. The Department wants to ensure that the application is user friendly for Ohio veterans and that veterans get the service they deserve when they begin applying for this bonus. DVS will use the general news media and their website www.dvs.ohio.gov to advise eligible veterans when they are ready to receive bonus applications. Nobody knows when the first checks will be mailed, but people who have experience with veteran bonuses in other states estimate that checks may not be issued for about one year. Ohio veterans who served on active duty during the Persian Gulf War or during current wars in Afghanistan and Iraq are eligible if they are current Ohio residents and were state residents for at least one year preceding their service.

Several government procedures have to be carried out before the bonus application process can begin. First, the Issue One resolution will not take effect until the Ohio Secretary of State certifies the election results. After the election is certified, DVS will adopt rules regarding the bonus and the Ohio Joint Committee on Agency Rule Review must certify these rules. Then, the Ohio Public Facilities Commission must create and sell the bonds. DVS also must hire and train a staff to efficiently process the bonus applications. All applications will be screened in detail to determine that each veteran qualifies for the bonus. DVS is working hard to ensure the bonus application and approval process is simple and efficient.

How much money will each person receive? Fifty dollars for each month of active domestic or foreign service and one hundred dollars for each month of service in the combat zones of the Persian Gulf, Afghanistan or Iraq during the specific periods of time. The maximum amount payable to any person in active domestic or foreign service is \$500. The maximum amount payable to any person in Persian Gulf, Afghanistan or Iraq service is \$1,000. A person who is medically

discharged or medically retired from service due to combat-related disabilities sustained during Persian Gulf, Afghanistan or Iraq service is entitled to \$1,000.

This Week in Guard History. Nov. 12, 1940: Milwaukee, Wis. --- As war raged in Europe and the very real possibility that the U.S. might be attacked was present in most people's minds, the Army authorizes the organization of seven new observation squadrons in the National Guard, even as Guard units are being mobilized for their one year of "emergency" training in case of war.

On this date, the 126th Observation Squadron receives federal recognition at Milwaukee. It is organized and commanded by Maj. Paul Meyers, the first American aviator in World War I to receive the French Croix de Guerre (Cross of War) Medal for valor in combat. The unit flew obsolete North American O-47B observation aircraft. Unlike prewar observation squadrons, the 126th was not assigned to a Guard division. It was assigned directly in support of the II Army Corps and performed various duties, including photographing portions of the Carolina Maneuvers in the autumn of 1941. During the war, it served in a photographic reconnaissance role in the European Theater as part of the 9th Air Force and XII Tactical Air Command. After the war, the 126th was first reorganized as a fighter squadron, but, in 1962, it had a change of mission, converting to an aerial refueling unit flying the KC-97 Stratofreighter. In 1977, they were re-equipped with the KC-135 Stratotanker.

Recent News Releases

Three Ft. Hood Victims Had Prior Guard Experience. Three former National Guard members were among those honored this week at a memorial service at Fort Hood, Texas, where a lone gunman shot and killed 13 people and wounded 30 on Nov. 5. Maj. Nidal Malik Hasan has been charged with 13 counts of murder. The Army psychiatrist was shot several times to end the violence at the base. He was awake this week and had met with his lawyer.

The former Guard members killed were: Lt. Col. Juanita L. Warman, who worked with the Maryland Army National Guard's reintegration program; Michael Cahill, a civilian employee at Fort Hood who had served with the Montana Army National Guard; and Capt. John Gaffaney, a psychiatric nurse who once served with the California Army National Guard.

In the wake of the tragedy last week, Gen. Craig McKinley, chief of the National Guard Bureau, released a statement saying, "The thoughts and prayers of the National Guard are with Fort Hood soldiers, their families and the local community today." About 2,000 current Guardsmen were stationed at the sprawling Texas base at the time of the shooting, according to the National Guard Bureau. Their states were using social media to provide updates on the status of their troops as the information became available.

On Tuesday, President Obama attended the memorial service and praised the diversity of the military. "They are man and woman. White, black and brown. Of all faiths and all stations," he said. "All Americans, serving together to protect our people, while giving others half a world away the chance to lead a better life."

President Declares November Military Family Month. President Barack Obama has declared November as Military Family Month. The proclamation reads:" No one pays a higher price for our freedom than members of our nation's military and their families. As sons and daughters, husbands and wives, and mothers and fathers are deployed, military families endure with exceptional resilience and courage. They provide our troops with invaluable encouragement and love, and serve our nation in their own right. During Military Family Month, we honor the families of our armed forces and thank them for their dedication to our country.

"Though only a small percentage of our nation's population, our troops bear the great responsibility of protecting our people. They, along with their families, serve us every day with courage and dignity. Ensuring that military families receive the respect they deserve and the support they have earned is a top priority for my administration.

"The strength of our nation is measured not just by our success on the battlefield, but also by our ability to support those families who have made so many sacrifices for us. Time and again, military families have shown their heart in the face of adversity. We have a solemn obligation to ensure that while our men and women in uniform discharge their duties, we do all we can to promote and preserve the well-being of their families. We must also support the families of our wounded warriors and our fallen heroes who have paid the ultimate price for the freedoms we enjoy. ...

"Now, therefore, I, Barack Obama, president of the United States of America, by virtue of the authority vested in me by the Constitution and the laws of the United States, do hereby proclaim November 2009 as Military Family Month. I call on all Americans to honor military families through private actions and public service for the tremendous contributions they make in the support of our service members and our nation."
